Welcome to the April edition of the MGCC Newsletter. A lot of progress has been made since our last communication, and this newsletter provides a snapshot for members regarding where we are at with the bushfire insurance claim and, more recently, the unfortunate closure of the golf club and golf course, due to the government restrictions regarding the CORONA Virus.

Bushfire Update

In January 2020, Zurich Insurance (the MGCC Insurance Company) provided a progressive payment of \$50K to commence work on the golf course. Contractors worked on the back 9 holes to remove dangerous and dead trees, and the 18 holes were soon open for play. As part of this payment, contractors also cleared debris on the 4th, 5th, 7th and 8th fairways, and members may have noticed the heavy machinery working over a four-day period. This provided an excellent snapshot of what could be done in a short amount of time, and what decisions the Committee of Management will make regarding the clearing of debris in the very near future.

For three long months, the MGC's Insurance Broker, Mr Malcolm Hills (Austbrokers Countrywide), worked assiduously with the Committee of Management interpreting and negotiating the MGC's Insurance Policy, and negotiating with Zurich Insurance, specifically around the removal of debris and determining what constitutes debris. We are now pleased to announce that notice has been received from Zurich Insurance that the "Material Damage" claim has been accepted, that is, for the removal of damaged trees which is covered under the item removal of debris cover in the policy.

We cannot thank Malcolm Hills enough for his tireless efforts on behalf of the MGC.

Currently, we are awaiting the outcome of the "Business Interruption" claim associated with the recent bushfire, from Assessors Crawford Global Technical Services, Business Interruption claims are triggered when there is damage to insured property (as is this case following the bushfire). Unfortunately, Business Interruption Insurance does not cover business interruptions due to a Pandemic, Mallacoota Golf Club closed at the end of March and the clubs Business Interruption claim will be calculated for the January to March 2020 period.



CORONA VIRUS

Further to directions from Victoria's Chief Health Officer, on 23 March 2020, the MGCC Committee of Management closed the clubhouse, bar and golf shop. Keith Allan followed suit and closed the kitchen. On Saturday 28th March 2020, at 5pm, the golf course was officially closed.

A Media Release on the 2nd April 2020 from the Victorian Chief Health Officer reiterated the necessity to take physical distancing seriously, and stated that "Unfortunately, this means no fishing, no hunting, no boating, no camping, and no golf. Hang up your rods, leave the tinnie in the driveway, and clean your clubs at home." Further, Professor Sutton said "We ask Victorians to stop looking for loopholes. Just do the right thing. The advice is clear; by staying at home you're saving lives. These restrictions are tough, but they are there for a reason. If we don't do this, Victorians will die. No round of golf or gym session with your mate is worth that cost".

Whilst the golf club and golf course are closed, basic work continues in order to maintain the fairways and greens. Since the Bushfires, we have come a long way getting the greens back to an acceptable standard, and John Bell and a few volunteers continue to work on the course to ensure the current standards are maintained. John and his small crew are practising safe distancing and regular handwashing practices, and we thank them for their work and dedication.

Club members should be aware that, with the closure of non-essential businesses, the Mallacoota Golf Club, like many other businesses, is not generating an income. Bar staff and kitchen staff are without work. The Committee of Management has applied for a grant of \$10,000 through the Victorian Government Business Support Fund, specifically to meet business costs, including utilities and loss of rent. Further, the club has registered with the Australian Taxation Office for Job Seeker funding.

Be assured the Committee of Management is working hard on your behalf.
